1. _____ In addition to and in accordance with A V Party Rental Contract # _____,
Date _____, Client _____
2. _____ INSTALLATION AND REMOVAL SCHEDULE: Installation may take place several days before and/or removal several days after, at the reasonable discretion of A V Party Rentals.
3. _____ SITE PREPARATION: Customer agrees to have the site clean and clear of obstacles that prevent access to or installation of the equipment. Customer agrees to an additional charge for any delay incurred, or additional labor performed by A V Party Rentals, resulting from Customer's failure to do so.
4. _____ NECESSARY PERMITS & LICENSES: Customer agrees, prior to installation of the equipment, to obtain, at Customer's expense, all necessary permits, licenses and other consents. For an additional fee, Customer may contract with A V Party Rentals to obtain necessary permits.
5. _____ CANCELLATION: Deposits on reservations cancelled less than one week prior to event are **non-refundable**. All cancellations are subject to fees and services already disbursed.
6. _____ SUBSURFACE CONDITIONS: Customer agrees to inform A V Party Rentals in writing of the existence of any underground pipes, cables, conduits, etc. that might interfere with A V Party Rentals' ability to stake and/or anchor the equipment. In the absence of such notice, A V Party Rentals assumes that no underground obstructions exist. Customer shall reimburse A V Party Rentals for additional costs incurred as a result of undisclosed subsurface conditions. **A V Party Rentals is not responsible for damage to underground obstacles.**
7. _____ HOLD HARMLESS: Customer will take all necessary precautions regarding the items rented, and protect all persons and property from injury or damage. Customer agrees to indemnify, defend and hold harmless A V Party Rentals from and against any and all liability, claims, judgments, attorneys' fees and costs, of every kind and nature including, but not limited to, injuries or death to persons and damage to property, arising out of the delivery, installation, removal, use, maintenance, instruction, operation, possession, ownership or rental of the items rented, however caused, except claims or litigations arising through the willful misconduct of A V Party Rentals. **Note: When canopies or tents are placed in close proximity to buildings or permanent structures, there is a greater possibility of property damage. Customer agrees that A V Party Rentals will not be responsible for any property damage that may occur due to delivery, installation, removal, or placement of tents or canopies.**
8. _____ SECURITY: Customer is responsible for the security of equipment from installation through takedown.
9. _____ WATERPROOF: Although the canvas and vinyl products or the equipment have been treated for water repellency, they cannot be guaranteed to be waterproof.
10. _____ The equipment described above is subject to prior sale, pending our acceptance of this agreement. This proposal may be withdrawn if not accepted within _____ days.
11. _____ Drivers/Delivery personnel do not have the authority to deviate from this or any other A V Party Rentals policy.
