DISCLOSURE FOR CONFESSION OF JUDGMENT:

I/We are executing, this _____ day of _____, _____ a Credit Application obligating me/us to pay any amount due to **GEORGE'S TOOL RENTAL, INC.** for rental or purchase of equipment or materials on credit.

- A. I understand that the Guarantee of Obligation contains a Confession of Judgment provision that would permit **GEORGE'S TOOL RENTAL, INC.**, to enter judgment against me in court, after a default in payment of any amount due, without advance notice to me and without offering me an opportunity to defend against the entry of judgment. In executing this Credit Application, being fully aware of my rights to advance notice and to a hearing to contest the validity of any judgment of other claims that **GEORGE'S TOOL RENTAL, INC.** may assert against me under the Confession of Judgment- I am knowingly, intelligently, and voluntarily waiving these rights- including any right to advance notice of the entry of judgment, and I expressly agree and consent to **GEORGE'S TOOL RENTAL, INC.**'s entering judgment against me by confession as provided for in the Confession of Judgment provision.

I further understand that, in addition to giving **GEORGE'S TOOL RENTAL, INC.** the right to enter judgment against me without advance notice or a hearing, the Confession of Judgment provision in the Credit Application also contains language that would permit **GEORGE'S TOOL RENTAL, INC.** after entry of judgment, again without either advance notice or a hearing, to execute on the judgment by foreclosing upon, attaching, levying on, taking possession of or otherwise seizing my property, in full or partial payment of the judgment, in executing this credit application, being fully aware of my rights to advance notice and a hearing after judgment is entered and before execution of the judgment, I am knowingly, intelligently and voluntarily waiving these rights, and I expressly agree and consent to **GEORGE'S TOOL RENTAL, INC.**'s immediately executing on the judgment, in any manner permitted by applicable state and federal law, without giving me any advance notice.

EQUIPMENT PROTECTION PLAN

Our Equipment Protection Plan is designed to help protect you from loss or damage to the equipment you have rented. The program provides that we will waive our right to recover from you the loss resulting from direct physical damage to and loss of rented equipment, such as that resulting from collision, upset, fire, vandalism, malicious mischief and other similar losses. We exclude from this plan, however, the loss, damage or theft of accessory equipment such as welding leads, gas cans, wrenches, chains, binders, bits, drill steel, etc. Also excluded is loss or damage due to misuse or abuse, theft by conversion, intentional damage, mysterious disappearance or other loss due to your failure to care for the rented item in a responsible manner, taking every precaution to insure its safekeeping. The lessee is obligated to furnish George's Tool Rental a police report on all theft, vandalism, malicious mischief and similar type losses. In addition, if you have insurance for the loss or damage, you shall exercise, and shall empower us to exercise, all your rights to obtain recovery under insurance, shall cooperate with George's Tool Rental to obtain recovery and all insurance proceeds shall be given or assigned to George's Tool Rental.

The cost of this Protection Plan is 12 percent of the total rental for all rented equipment. When you compare our protection plan charge to the cost of insuring rented equipment under a contractor equipment floater policy, we believe you will find that our charge is nominal, particularly, since you are paying for this protection only for the period you rented the equipment.
